- OSSA Report
  - Members of the board attended the May 3<sup>rd</sup> State Championship OSAA committee meeting.
  - The OSAA has passed the following proposals:
    - To reduce minimum dance division requirements at 4A level to 5 teams to have a standing division.
    - To reduce minimum dance division requirements at the 3A/2A/1A to 5 teams to have a standing division.
    - To establish 6A and 5A division cut-off points and to revise process used to combine divisions when insufficient entries.
      - This will be in effect for the 2010-2011 dance team season. Small division will be 10-20 member team size. Large division will be 21-50 member team size. In the event that less than 8 teams are registered for a division they will

combine with like size (example: 5A and 6A large would combine - OR - 5A and 6A small would combine)
